BOROUGH ORDINANCE 15-06

PENALTY FOR VIOLATION: ANY VIOLATION OF THIS ORDINANCE SHALL CONSTITUTE A SUMMARY OFFENSE PUNISHABLE UPON CONVICTION THEREOF BY A MAGISTERIAL DISTRICT JUDGE, BY A FINE NOT TO EXCEED SIX HUNDER DOLLARS (\$600.00) PLUS COSTS OF PROSECUTION OR IN DEFAULT OF PAYMENT OF SUCH FINES AND COSTS, BY A TERM OF IMPRISONMENT NTO TO EXCEED THIRTY DAYS, EACH DAY OF VIOLATION SHALL CONSTITUTE A SEPARATE AND DISTINCT OFFENSE.
